

### **Arms Control in the Nuclear Realm**

# **Course Description:**

This course focuses on the notion of nuclear arms control as understood from the perspective of international relations studies. The course will highlight the motivation for developing nuclear weapons, how they are viewed by states and by the international community, and the strategic dilemmas that states face when they attempt to negotiate arms control agreements in the nuclear realm, as well as the strategic significance of the agreements themselves. We will be looking at the history of attempts to negotiate arms control and nonproliferation agreements, including the experience in the Middle East in the early 1990s, and at the different international contexts for negotiating arms control: UN, regional frameworks, and bilateral dialogues.

In conceptual terms, controlling the negative effects of nuclear weapons will be examined and discussed in light of the two major traditions that developed over the course of the second half of the 20<sup>th</sup> century: disarmament (with its focus on weapons), and "stabilization of relations" (with its focus on states). We will also examine the major proliferation challenges of the post-Cold War – Iran and North Korea – and assess developments in arms control thinking in light of the experience of international attempts to curb these two states' nuclear ambitions.


