Each course ends with an examination which can be of various types.<br/>Break over Christmas depends on each specific course schedule.Language of instructionEnglishFull time study load30 credits (ECTS) per semester. Courses are normally worth 15 credits.<br/>Students choose two 15-credits courses each semester. One week of full-time<br/>studies equals 1.5 credits. The workload is 40 hours per week, including<br/>lectures, reading assignments, seminars and independent studies.

General information about the Swedish Law Programme

The law programme of 4,5 years leading to the Swedish Master of Laws Degree LL.M. (in Swedish: *Juristexamen*) is the standard law programme in Sweden. The Law Programme is mainly taught in Swedish. The degree is required for professions such as that of a judge, attorney at law and prosecutor.

The standard law programme consists of compulsory courses taught over a period of 7 semesters. After this, in their fourth year, students can choose from app. 60 specialized courses. *Approximately 20-25 of these specialized courses are given in* **English** and are open to both foreign exchange and Swedish law students. Foreign exchange students who are proficient in Swedish may also apply to attend the courses taught in Swedish but there is subject to availabilities and this cannot be guaranteed. Most courses end with a written examination.

## Application information – Semester/Full Year Exchange programme

Nomination deadline	For autumn semester 2024 (or full academic year) - 30 April 2024 For spring semester 2025 – 30 September 2024 Nominations will be sent in from partner university coordinators via an online form. The link will be sent out to all partners in February 2024. Unless stated otherwise in our agreement, we ask you to nominate your yearly quota of students equally between the autumn and the spring
Application	semesters. All students must officially be nominated by their home university to be eligible for an exchange at the Department of Law. After the nomination is received, the students will be given access to the application.
Application deadlines	For autumn semester 2024 – 10 May 2024 For spring semester 2025 – 10 October 2024
Application material required	In two steps, first: <b>Online form</b> and the most recent copy of <b>Transcript of</b> records in English, and later Course selection form.
Academic requirements	All our courses are on an advanced level. Your students are therefore required to have studied <b>at least 120 credits in law (i.e. 2 years of fulltime studies)</b> in order to to take our courses. Please know that students who join us during the 1 <sup>st</sup> semester of their 3 <sup>rd</sup>



Language requirements	year might struggle with a knowledge gap if they have no previous studies in the particular area of law that they choose to study here in Stockholm. While we only require 120 ECTS, your students will preferrably have at least 2,5 years of fulltime studies within law before joining us. Students whose mother tongue is not English are recommended to have at least a level of B2-C1, or equivalent of an overall IELTS score of 6.5 or an overall TOEFL score of 100 internet-based (or 575 paper-based. Note that since April 11, 2021, the TOEFL paper test is no longer offered). We do not need to see the test results but ask all our partners to make sure their students have this level before nominating them to us.

Course catalogue	<u>Course catalogue (law)</u> The page will be updated as soon as information is available. Please note that the list might be subject to change.
Swedish language course	<u>Swedish language courses</u> on different levels are offered for free by the Department of Swedish Language and Multilingualism to all incoming exchange students. More information about language courses are given on Orientation Day.
Course Attendance	Please note that all our courses have <b>mandatory active attendance</b> . This is means that students are expected to come to their classes well-prepared and ready to actively discuss the contents of the day's lecture/seminar/etc. For optimal class dynamics it is therefore very important that your students meet our language requirements and are prepared for this style of teaching.
Transcript of record	Students can issue an official transcript of records through our student portal. This comes with a verification code (bottom of the page). If you require a hard copy, please state so in the nomination online form.
Application information –	Summer programme 2024
Nomination procedure	Nominations will open in the beginning of our spring semester 2023 with a deadline on March 31. Partners will receive details regarding the nomination process as well as the course schedules in January/February. All students must be officially nominated by their home university to be eligible for the programme. More information is sent out in a separate email in due time.
Application & Payment	The application and course selection deadline for students is 10 April. Payment for those who after the course confirmation choose to attend the programme in Stockholm will be due on 21 April.
Language requirements	Students whose mother tongue is not English are recommended to have at least a level of B2-C1, or equivalent of an overall IELTS score of 6.5 or an overall TOEFL score of 100 internet-based (or 575 paper-based. Note that since April 11, 2021, the TOEFL paper test is no longer offered). We do not need to see the test results but ask all our partners to make sure their students have this level before nominating them to us.
Courses	The courses in 2024 are only in Law. We offer courses on both basic and advanced level. For access to the advanced level courses, your students have to have 2 years of fulltime studies in Law. For courses at basic level, the academic requirement is one year of fulltime study at the university level. Registration	Course registrations are made by students around one week before the semester starts. Information is sent out in advance to all incoming students.
Visa	Studying in Sweden – Swedish Migration Agency.
	<b>NOTE:</b> The Swedish Migration Agency has recently introduced new rules for better passport checks. Starting on 1 November, 2022, applicants for a permit to study or conduct research in Sweden may now to need personally show their passport before the Swedish Migration Agency can make a decision. Students may face longer waiting times.
Insurance	All incoming students will be covered by the state insurance Student IN
